INTRODUCTION

Introduction

The Census is a count of the entire population of the United States occurring every ten years as required by the U.S. Constitution. The Census Bureau collects data for various attributes of the population including race, age, gender, income, housing, education, transportation and employment.

Various people and groups use Census information, including federal and state government, community leaders and planners, and businesses. Census information is used for many purposes such as:

- The Census count determines the number of congressional representatives assigned to each state (*reapportionment*).
- Census numbers are used to redraw boundaries of legislative districts (*redistricting*).
- Federal and state funds supporting schools, employment programs, housing, roads, hospitals and programs for the elderly are distributed based on Census figures.
- Community leaders and planners use Census data to help decide where to locate new roads, schools, parks and help plan for other community services.
- Because Census data has been collected for so many years, the Census provides useful historical information on demographic changes. For example, planners can study how a town or a city's *population density* has changed over time.
- Businesses use Census figures in their planning and decision-making such as planning for investments, analyzing trends and understanding consumer needs.

Census data is collected through surveys sent to each *household* in the country. By law, all individual responses are kept confidential and are not shared with any other government agency. These responses are summarized and organized as data that is made available for different geographic areas, such as at the state, county and city levels. Census data are also reported for various administratively defined areas such as block groups or Census tracts. *Census tracts* are small areas within communities that generally have an average of 4,000 residents.





Figure 2: Census Tracts 2010

Census tract boundaries generally remain the same from Census to Census to allow for comparison of data from several Census years. In 2000, Amherst was composed of 23 Census tracts. In some cases, however, the boundaries change. In 2010, this was the case for Amherst as shown in Figures 1 and 2. In 2010, two tracts were split to create two new tracts for a total of 25. However, for the purposes of comparison between 2000 and 2010, the Census tract boundaries for 2000 were used and data for the new tracts were combined to maintain geographic consistency.

This report contains Census information and maps for the Town of Amherst. It compares data from the 2000 and 2010 Census to get an understanding of how the Town has changed in the past decade. The report also compares Amherst with the data for Erie County, and the City of Buffalo. Data for the Village of Williamsville is also included in the report. It covers four main areas:

- Population
- Age and Gender
- Households and Families
- Commuting and Employment

The following are useful definitions relating to the Census (full definitions are available at www.census.gov):

General

Census tract

Small areas within counties and municipalities that generally have an average of 4,000 residents for which Census information is organized. The boundaries of Census tracts generally follow visible physical features, such as roads or streams.

Reapportionment

The redistribution of seats in the U.S. House of Representatives among the states on the basis of population distribution observed during the most recent Census.

Redistricting

The process of revising the geographic boundaries of areas from which people elect representatives to the U.S. Congress, a state legislature, a county or city council, or a school board, to meet the legal requirement that such areas be as equal in population as possible following a Census.

Population

Total population

Complete count of all persons residing in an area.

Population density

Total population divided by some measure of area. (Example: persons per acre)

Housing Units

Housing unit

A house, apartment, mobile home, or trailer.

Owner-occupied housing unit

A housing unit is owner occupied if the owner or co-owner lives in the unit.

Renter-occupied housing unit

All occupied units that are not owner-occupied are classified as renter-occupied.

Households

Household

A household includes all the people who occupy a housing unit as their usual place of residence.

Householder

The person, or one of the people, in whose name the home is owned or rented.

Household density

Total households divided by some measure of area. (Example: households per acre)

Household size

The total number of people living in a housing unit.

Median Household Income

The amount which divides the income distribution into two equal groups, half having income above that amount, and half having income below that amount.

Family household

A family includes a householder and one or more people living in the same household who are related to the householder by birth, marriage, or adoption.

Non-family household

Household composed of unrelated people or one person living alone.

Group quarters

The Census Bureau classifies all people not living in households as living in group quarters. There are two types of group quarters: institutional (for example, correctional facilities, nursing homes, and mental hospitals) and non-institutional (for example, college dormitories, military barracks, group homes, missions, and shelters).

Figure 1: Census Tracts 2000

Total Population

- Erie County’s population continued to decrease, from 950,365 in 2000 to 919,040 in 2010, a loss of 31,325 persons, or a decrease of 3.3%.
- The City of Buffalo experienced a 10.7% loss in population over the decade, declining by 31,338 persons.
- The Village of Williamsville experienced a slight decline in population, a loss of 4.9% over the decade.
- Between 2000 and 2010, the Town’s population grew from 116,510 to 122,366, an increase of 5.0%. However, this growth was not evenly distributed. Much of it occurred in tract 91.10, with an increase of 29.1%. This growth in population is attributed to the continued expansion of UB as demand for student housing continued to increase. The greatest decrease (-4.5%) occurred in tract 89.00, around the Village of Williamsville.
- Overall, Amherst represents a larger portion of Erie County’s total population, growing from 12.3% in 2000 to 13.3% in 2010.



Population Density

- The population density in Erie County between 2000 and 2010 stayed constant, at 1.4 persons per acre. In the City of Buffalo, however, the population density was much higher, from 11.3 persons per acre in 2000 and 10.1 persons per acre in 2010.
- In the Town, the population density in 2000 was at 3.4 persons per acre and at 3.5 persons per acre in 2010.
- In the Village, the population density in 2000 was at 6.9 persons per acre and declined to 6.6 persons per acre in 2010.





White Population

- There is a continued decrease in the County’s total white population since 2000. This population declined from 780,942 in 2000 to 735,244 in 2010, a loss of 45,698 persons or a decrease of 5.9%.
- Amherst experienced a slight decrease in its white population, from 104,018 in 2000 to 102,558 in 2010, or a decrease of 1.4%. While the total white population in Amherst decreased, some tracts experienced growth in its white population while others saw a decline. The greatest growth occurred in tract 90.03 in Northeast Amherst, accounting for a 16.8% increase. The largest decline occurred in Eggertsville (tract 93.01) with a (-15.7%) decrease.
- The Village experienced a decrease in its white population, a loss of 10.4% over the decade.





Black Population

- Erie County experienced a slight increase in its black population, from 123,529 in 2000 to 123,931 in 2010, a growth of 0.3%.
- The Village also experienced a significant growth in its black population, with an increase of 210.5% over the decade.
- Amherst experienced a significant increase in its black population, from 4,544 in 2000 to 7,009 in 2010, an increase of 54.2%. Much of this growth occurred in tract 93.02 in Eggertsville, from 82 to 216 persons, accounting for a 163.4% increase. This was followed by tract 89.00, growing from 29 to 72 persons, or a 148.3% increase.





Asian Population

- Between 2000 and 2010, Erie County experienced a substantial increase in its Asian population, from 13,835 in 2000 to 23,789 in 2010, a 71.9% increase – double the amount between 1990 and 2000.
- The City of Buffalo’s Asian population increased significantly, from 4,093 in 2000 to 8,409 in 2010, or an increase of 105.4%.
- The Village experienced a significant growth in its Asian population, from 53 in 2000 to 170 in 2010, an increase of 320.8%.
- Amherst’s Asian population grew, experiencing a 59.2% increase during the decade. This increase occurred throughout the Town, with recorded three-digit growth in the majority of its tracts. Much of the growth occurred in tract 90.08, with a population of 98 in 2000 to 465 in 2010, a 374.5% increase. This was followed by tract 93.02 in Eggertsville, from 45 to 132 persons, or an increase of 193.3%.





Other Populations

- Amherst is also home to other population groups that include: American Indian and Alaska Native; Native Hawaiian and Pacific Islander, as well as mixed races. At the county level, this group of the population grew by 12.9%, from 31,959 in 2000 to 36,076 in 2010.
- The Town experienced a substantial increase in this segment of the population from 1,870 in 2000 to 3,124 in 2010, or an increase of 67.1%. Much of the growth occurred in tract 91.10, from 39 in 2000 to 270 in 2010, an increase of 592.3%. This growth can be attributed to the continued expansion of housing related to UB, as more people from diverse backgrounds settle into areas of the Town near the campus.
- The Village experienced a 71.7% growth in this segment of the population, from 60 in 2000 to 103 in 2010.








Population Pyramids



A population pyramid is a diagram that shows the age and gender distribution of a population. Each horizontal bar on the chart shows the number of males and females in an age group. Population pyramids display the history of an area's population growth. They also provide important information to government leaders and planners because people of different ages have different needs. For example, the Town is seeing a burgeoning aging population that makes demand for services and accessibility significant considerations. At the same time, there is also an increasing cohort of 18 to 24 year olds related to the expansion of UB that could drive land use and development in areas near its campuses due to increased demand for student goods and services.

- Figures 14 and 15 show the population pyramids for the nation in 2000 and 2010. The charts are generally large on the bottom and narrower on the top as the death rate is higher among older people than younger people. The largest age categories however, occur in the middle of the chart. In 2000, 35 to 44 years old was the largest age group. In 2010, the largest age group was 45 to 54 years old, illustrating the overall aging of the American population. There is also a slightly higher number of children under 10 years old in 2010.
- Figures 16 and 17 show the population pyramids for Erie County. The charts follow the same general pattern as those of the nation, with 35 to 44 years old as its largest age group in 2000 and 45 to 54 years old as its largest age group in 2010.
- Figures 18 and 19 show the population pyramids for the Town of Amherst. In 2010, the Town's population is growing at two extremes: it saw a substantial increase in population in its 18 to 24 year old age group due to growth in students, and its 55 to 64 year old age group as a large number of residents continues to age.

More detailed information for each age group category and gender is provided in the following sections.







Under Five Years

- The Census Bureau reported that the nation experienced a slight increase of 5.3% in its under five year old age group, growing from 19,175,798 in 2000 to 20,201,362 in 2010.
- At the County level, this age group declined from 57,837 in 2000 to 49,038 in 2010, a decrease of 15.2%.
- The City of Buffalo experienced a similar loss as the County, with a decrease of 16.2%.
- The Village experienced a 12.2% loss in this age group, from 278 in 2000 to 244 in 2010.
- The Town experienced a smaller decline in this age group, from 6,270 in 2000 to 5,762 in 2010, a decrease of 8.1%.

- The Census reported a loss in this age group, from 20,549,505 in 2000 to 20,348,657 in 2010, a decline of about 1%.

- An increase in the 15 to 19 year old age group was experienced at the national, County and Town level. However, the growth at the Town level surpassed that at the national and County level. At the national level, this age group increased by 9.0%, while at County level, it was recorded at 3.3%.

Households

Total number of households

- The Census reported a slight increase of 0.6% in the total number of households in Erie County between 2000 and 2010. The number of households grew from 380,873 in 2000 to 383,164 in 2010. Amherst continues to represent a growing portion of Erie County's total number of households at 11.8 in 2000 and 12.8% in 2010.
- The total number of households in Amherst is shown in Table 26 and Figures 24 and 25. The Town experienced a much more substantial increase for the decade than the County. It increased from 45,076 in 2000 to 48,894 in 2010, or an 8.5% increase.
- Some of the tracts saw more growth than others. The greatest increase occurred in tract 90.03, from 2,968 in 2000 to 3,962 in 2010, or an increase of 33.5%. This was followed by tract 96.00, with the total number of households growing from 2,373 in 2000 to 3,091 in 2010, or an increase of 30.3%.

Housing density

- The housing density for the Town increased from 1.4 households per acre in 2000 to 1.5 households per acre in 2010. Housing density varied by tract (see Table 28 and Figures 35 and 36). Tract 93.01 had the highest density at 5.2 per acre, followed by tract 93.02 with 4.2 units per acre. Both tracts are located in Eggertsville.

Household size

- Despite the growth in the number of households, the Town's average household size declined from 2.4 in 2000 to 2.3 in 2010 (see Figures 27 and 28).

Household types








Figure 30: Family Households 2010

- There were 29,899 family households in Amherst in 2000, accounting for 66.3% of all households in the Town. The number of family households in the Town decreased to 29,840 or 61.0% in 2010 (see Figures 29 and 30).
- Non-family household increased between 2000 and 2010, from 15,177 or 33.7% to 19,054 or 39.0% of all households (see Figures 31 and 32).
- The percentage of people living in group quarters in the Town grew during the decade, from 7,397 or 6.4% in 2000 to 8,364 or 6.8% in 2010. Much of the growth occurred in tracts 91.08, 91.13 and 92.00. These are tracts that surround UB (tract 91.10) and the growth is reflective of the increasing student housing developments in those areas (see Figures 33 and 34).










Owner Occupied Housing Units

- At the County level, the Census reported a slight decrease in the number of owner occupied housing units between 2000 and 2010. It declined from 248,767 to 248,229, a loss of 0.2%.
- The number of owner occupied housing units increased in the Town, from 33,349 in 2000 to 34,885 in 2010. Tracts 90.03 and 90.08 experienced much of this growth, with increases at 22.9% and 31.9% respectively (see Table 28 and Figures 37 and 38).
- In 2000, the Town made up 13.4% of Erie County’s owner occupied housing and increased to 14.1% in 2010.



- Between 2000 and 2010, median income in Erie County increased, from \$38,567 to \$47,372, an increase of 22.8%.
- The median income in Amherst grew, rising from \$55,427 in 2000 to \$64,620 in 2000, or an increase of 16.6% (see Table 30 and Figures 41 and 42).

- The median income in the Village also grew, increasing by 37.5% over the decade.






- The number of people who live and work within the same community declined across all jurisdictions, the most significant loss was experienced in the Village of Williamsville where the number of residents working there declined by 41.3%. Alternatively, the number of employees who commute to work outside the community where they live all increased except in the City of Buffalo.
- The number of Erie County residents who commute to work outside the County increased from 49,702 in 2002 to 59,504 in 2010, an increase of 19.7%. More Amherst and Williamsville residents are also commuting to work outside their home community. The number of Buffalo residents commuting to work in other communities declined by 2.5%.
- The number of people commuting to work in Amherst, Buffalo, and Erie County from outside those jurisdictions all increased. Persons commuting into the Village to work declined by 22.6%.
