Project Features:

- Resurfacing the full width of the pavement with asphalt milling and placement of asphalt overlay.
- Providing drainage structure repairs or replacement as needed.
- Upgrading sidewalk curb ramps to meet applicable ADA/PROWAG standards.
- Restriping Bailey Avenue within the project limits.

Additional Things to Know:

Motorists and residents can expect that there will be some traffic disruption during the construction project, including lane closures. Pedestrian traffic will be similarly disrupted from time to time. These disruptions will be kept to a minimum and will be communicated via a portable messaging sign and updates on the project website. Work zone operations will be coordinated with the Town, Erie County and New York State Agencies. Nighttime construction will not be permitted. There will be no permanent changes to the existing vehicular and pedestrian traffic patterns.
